Chairman Bilberry called the meeting to order at 9:00 AM.

PROCLAMATION

A proclamation declaring Thursday, July 28, 2022, as 4-H Champions Day in Chaves County, was read out loud by Commissioner Dana. A certificate was presented to the members of the shooting club that were present and a photo was taken with the Commissioners in the chamber.

PRESENTATIONS

Kim Chesser, 399 Chesser Road – Representing the Coalition of AZ/NM Counties

Mr. Chesser stated he was just at a meeting and wanted to give a brief update. A letter was presented at the meeting concerning the 30 x 30 movement that was initiated by President Biden. They are calling for a full environmental impact statement to be done because the NEPA Regulations require this by law. There were 15 Senators that signed on to this letter that was sent to the Council on Environmental Quality in Washington DC. At their meeting they decided that the Executive Director, Howard Hutchison, would draft a letter and send it in joining with the Senators telling them they need to do an impact statement. Counties will be able to look it over before it is sent. On July 1st, the Fish and Wildlife came out with new rules on the wolves. That day environmental groups filed a lawsuit saying that they disagreed and wanted to change some things. They want the wolf to be changed from non-essential to essential. If that happened, it would destroy all private property rights. They are looking to file their own lawsuit and they have given Howard the go ahead to do the research on what it would cost to carry this case. There was a big case that was won between Virginia and the Environmental Protection Agency. The Supreme Court ruled that the EPA overstepped their bounds with air quality. This should have big implications because there has been a lot of government overreach over the years.

They give out awards each year to recognize elected county officials, state employees, and other individuals in Arizona and New Mexico that go above and beyond their duties to advance the mission of the Coalition of Counties. There is a high bar to receive an award. They are pleased to present the following award for 2021. The award will go to Bill Williams, Chaves County Manager, who has been selected as the 2021 New Mexico State Employee of the Year. He consistently goes above and beyond his job requirements to advance the mission and policies of the NM and AZ Counties Coalition. A plaque was presented to Mr. Williams and a photo was taken.

Border Soil and Water Conservation District Rosemary Thomas, 146 Caballo Road, Roswell Deena Kinman, 2098 S Roosevelt Road, Elida

Ms. Thomas stated she is on the board for the Border Soil and Water Conservation District which was founded in 1941. Deena is the District Manager. They have updated their land use plan and have provided the Commissioners with a copy. Their land use plan is an executable policy for natural resource management and land use on district lands. Ms. Thomas gave the boundaries of the conservation district which is around 1.2 million acres with around 700,000 acres of that being private land. They partner with the Federal Government and other agencies to find out what funding sources are available. They become familiar with what their constituents are interested in and get the two together, so funding is available to private individuals. They can apply for and administer grants. They acquire grass seed to help repair and restore lands and prevent erosion. They have done local tree sales for wind breaks and have been involved in supporting cloud seeding. This is a way to enhance rainfall from existing cloud systems and get more rain on the ground. A copy of the report on cloud seeding was given to Commissioner Bilberry. They were able to get a license to cloud seed only in May and June and in that time, there were only thirteen or fourteen days they could do missions. They feel like they increased rainfall by approximately twenty percent. They have put in for a grant from the State of New Mexico to continue that for another three years. Some other programs they are involved in include enhancement for ranching management and farming, Ag business, working with natural conditions such as drought and erosion, and they support education of Ag business for youth by coordinating with schools.

Deena shared they are a cooperating agency. She thanked the County for the allocation they receive each year of \$1,000.00. Their main funding comes through the Legislature. The maximum amount they can be awarded each year is approximately \$14,500.00. This is used for Soil and Water Conservation resources, on the ground projects, and education. Ms. Thomas stated they would like to come back and visit every six months. Currently they are involved in a lot of water projects and helping producers find funding. Ms. Kinman said they would like to provide a cost share for private landowners and producers to combat African Rue.

Mike Espiritu, Economic Development Corporation

Mr. Espiritu stated it's a pleasure to be a part of their team and support economic development in Chaves County. They had their annual meeting and he thanked Commissioner Taylor for attending. Next month he hopes to give a good presentation on last year and going forward for next year to give them a good sense of where they are headed. Last year they visited 480 businesses trying to help them with growth. They helped several businesses receive funding through the job incentive training program. They exceeded all their goals last year and he will present that next month. They currently have several projects in the works. Next year they will be doing a complete redesign of their website. They have a robust marketing strategy for the coming year and did receive some additional funding from the city. They will continue to visit about 40 businesses a month. There is a new Automotive and Welding Facility at Eastern New Mexico University Roswell. We have great programs at our university, and we see a lot of folks from Chaves County leave to go do those same programs some place else. We would like to keep people here to be great employees. He encouraged them to coach others about the amazing resources we have at this campus. ENMU-R is offering an advanced aircraft maintenance technician program. They are working with Job Corps to bring in students from all over the country to Roswell into this program. He's hoping young people will come here and stay here.

The food is donated by Tractor Supply for this canine as well as their other one. They are both currently on duty, and have been commissioned and sworn in.

Marvin Clements 6102 Kinçaid, Lykins Subdivision

Mr. Clements stated he has been here before and is back here doing the same complaint. His neighbors have gotten worse. He would like to have some sort of resolution to this problem. They dismantle cars down there and he understands there isn't supposed to be a wrecking yard in a residential area, they have no septic tanks, there are all kinds of motorhomes and camp trailers. One piece of property on Hobson has seven or eight motorhomes parked on the property. He tells Louis that no one lives there but two people but every one of the campers has lights on at nighttime. On the Chips property the guys dismantle cars with an ax. They have no water, no sewer, no septic. He complained to the environmental lady, and she says she has to give them time to make updates, but nothing happens. There's a lot of traffic and now there are homeless people living in one of the abandoned houses. They cook outside every night. He doesn't know where they use the bathroom at. They dump oil on the ground. If we have an ordinance, why can't we do something.

Charles Yslas, Chaves County Undersheriff

Mr. Yslas stated they understand Mr. Clement's complaints and he is personally working hand in hand with Louis. They are looking at State statutes and County ordinances and doing everything in their power, but they have to stay within the law. On some of the violations there are time frames. They have involved environmental agencies for any type of septic issues and things like that. They are working to resolve this issue for Mr. Clements and the neighborhood.

He sits on the board for the Roswell Gun Club and on the 21st of this month they have a meeting. There was an overgrowth of weeds at the Gun Club, and they use this range for qualification purposes. He put the President in contact with Justin Porter, Detention Administrator. He thanked Mr. Porter as well as the work release program for cleaning it up. They did an outstanding job. The Gun Club is a 501C3, so they are non-profit.

Mike Herrington, Chaves County Sheriff

Sheriff Herrington stated they have a concern over the increase of homeless people in Chaves County. They are moving out into the County, and they are everywhere. They are coming in on busses. The individuals they have talked to said Albuquerque is giving them \$50.00 and putting them on a bus to us. The group they have encountered that has come here recently is volatile. They have mental illness problems and become angry and aggressive quickly. They are in the process of trying to figure out what they can do. He has met with Mayor Jennings. We have quadrupled the number of homeless in two months. They tell them to go to the mental health facilities, but they will not go. The Sheriff's Office just went through psychology training and when they, (the homeless), have schizophrenia, they don't know what voice yours is. They don't know who is telling them what. We will have some serious consequences in Chaves County if we don't come up with a plan to deal with this. The group here now is very territorial towards those who are coming in. When they were removed from the riverbed up north, they were introduced to the city and they are everywhere, sometimes getting a drink out of our back yard water hose. He is working on solutions.

Rita Kane Doerhoefer - Online

Ms. Doerhoefer stated she went to take a look at the situation as a member of the ETZ Commission and it is not a pretty site, it's not acceptable. She was scared to get out of her truck on the second property on Ryan. It's a hazard and probably and environmental problem. She would not go there at night.

MANAGER'S COMMUNICATIONS

Mr. Williams stated it was a good thing to see the 4H group here this morning especially since they are doing the county fair now. They did a wonderful job representing our community. He and Commissioner Cavin just got back from NACO. They talked about the usual issues we have here, Waters of the United States, 30x30, changes to grazing regulations, alternative energy plans, and managing of the forest. He thanked the Arizona/New Mexico Coalition of Counties for the plaque and recognition. It is a real honor to work with and for this group and hold up the ideals we have here in the southwest. Road Department is getting closer to wrapping up their chip seal for the year. They have done a lot of miles and continue to do a good job. He congratulated Brian Houghtalin as the new assistant flood control director. They have been working with the State to continue our building inspection program because Brian was the building inspector. Those inspections are a valuable asset to our county. He's reached out to contractors because it's in their best interest to help us to find people to fill these positions. If you know of anyone that has construction experience and is looking for a career, send them to the county website. He thanked the whole county staff.

COMMISSIONERS' COMMUNICATIONS

COMMISSIONER TAYLOR

Commissioner Taylor stated he attended the Economic Development's annual luncheon yesterday and it was very interesting. It was very positive. Economic development is still our main goal here, agriculture has been a big base for us, but now it's the Airport. We all have concerns about agriculture with the dryness and drought. He noticed this past week in central Texas that the farmers didn't even plant. 70 to 80% of the land doesn't have anything growing on it this year. A lot of it is because they are worried about lack of water. At the meeting yesterday they also mentioned we are losing another Dairy. This is a concern to us as it affects our farmers here that are growing feed. We need rain and water; this drought is really hurting this part of the state.

COMMISSIONER DANA

Commissioner Dana thanked Andrew for reading Ms. Rita's comments. We're trying to implement Facebook and it's hard to implement some of this technology. There is a delay. She knows Ms. Rita has been laid up but she is still out and about. She thanked Mike for working with the group at the base and she is surprised environmental groups are not doing more to take care of this. She thanked Charles and Justin for representing the Gun Club. We're seeing more and more agriculture go out of business. Agriculture is changing as we know because of the rise of marijuana being legalized. We are seeing a shift towards the growing of marijuana. It was very nice to see former Commissioner Kim Chesser and the ladies from Border Soil and Water. It's nice to see when we do fund programs that the people come in and tell us exactly what they are doing. She appreciates that. She understands some people are leaving us and she is sad about this but also understands people need to leave and grow. Hopefully we can get back to full capacity. She is happy they were able to increase employee pay and benefits. It's an investment and great partnership.

COMMISSIONER EZZELL

Commissioner Ezzell congratulated the 4H team. He congratulated Bill Williams for the much-deserved recognition for his service. We do have a county fair going on and he will make arrangements for them to go in on the purchase of an animal in the amount of \$500.00. Anyone who wants to contribute can get him a check. He congratulated Anabel and her team for the successful completion of the budget process.

COMMISSIONER CAVIN

Commissioner Cavin stated he would like to echo all the things that the other Commissioners had already said. It's been a busy summer and they had a good trip to Denver. He stated it's amazing to work with such an amazing group of people here in Chaves County between all of the citizens and Commissioners. God bless Chaves County and America and let's finish July strong and he'll see everyone in August.

COMMISSIONER BILBERRY

Commissioner Bilberry stated he really appreciates everyone's hard work. He congratulated Bill for his well-deserved award and thanked him for what he does. He told the Sheriff, he appreciates him and his team working hard to keep us safe. Not a day goes by that he doesn't think about them and what they do. He appreciates all the commissioners as well.
