Bill Williams read the proclamation out loud and proclaimed the month of May 2023 as Motorcycle Awareness Month in Chaves County.

# UPDATE FROM THE CHAVES COUNTY COOPERATIVE EXTENSION OFFICE Presenters: Tamara Schubert, FCS/4-H Agent, and Drew Garnett, Extension Ag Agent

Ms. Schubert gave an update on the 4-H programs which are open to kids ages 5-18. This last year they had 239 youth enrolled along with 79 adults over the eight clubs that are active in the county. This was a 25% increase from the prior year. They held 12 countywide workshops for the youth. On the FCS side, they have five extension clubs in the county that provide three scholarships to area youth. They also provided 1200 books for newborns along with 120 nursing coverups for moms. Through the program, they also provided six leadership trainings.

Mr. Garnett stated in November of last year they provided five CEUs. They provided 105 pecan weevil traps which they ran out of in 27 minutes. He helped a local business in Chaves County develop a point of sale for their pesticides for homeowners. He averaged 22 house calls a month where he would help with horticulture issues or other issues they were having. They hosted the Southeast Ranchers Workshop. They restarted the master gardeners' program as well.

## UPDATE FROM ROBERT WEIDNER, RURAL PUBLIC LANDS COUNTY COUNCIL, INDEPENDENT LOBBYIST

Mr. Weidner stated he considers it an honor to represent Chaves County in Washington, D.C. He has been an advocate for access to federal lands in the West. His primary responsibilities for the county have been payment in lieu of taxes and secure rural schools payments. He shared the latest set of proposed regulations from the Interior Department. The Interior Department has proposed three new additions to the act without asking Congress to amend the act. They want to stop the use of federal lands as well as block access. He has been working to fight this administrative overreach. The new Interior Secretary from New Mexico has endorsed this agenda and her primary objective appears to be to add more restrictions to the use of the land. He discussed LATCF payments to counties.

Mr. Williams stated the county has received one payment so far of \$3.93 million dollars and the total of the two payments Chaves County will receive is \$7.8 million dollars. Counties that were harmed by governmental policies over the last 20 years was the criteria for the LATCF funding.
