UPDATE FROM THE ROSWELL-CHAVES COUNTY ECONOMIC DEVELOPMENT CORPORATION

Presenter: Mike Espiritu, President and CEO

Mr. Espiritu stated they will be holding a Site League forum. American Airlines is projecting January for Phoenix flights to return but it could be longer. We are the smallest community they serve. Dean Baldwin received a JTIP award. The Alpha 5 Project is a five-person tandem jump off of a balloon. Their window is from the middle of September through the middle of October. This will be a national media event. The purpose of this project is to generate donations to help fund the scholarship program for the families of fallen special operations persons. The Reno Air Racing Association is moving from Nevada after being there for almost 60 years. In 2019 the number of visitors was 70,000 people for one event and the economic impact is over 100 million dollars. The EDC has a full team of people that have sent off a proposal. RARA will make a decision at the end of this year. Ascent Aviation is relocating out of Roswell. The EDC does have a company that is coming back for a second site visit to the bus plant.

UPDATE - FLOOD COMMISSION

Presenter: Brian Houghtalin, Flood Director

Mr. Houghtalin stated the Flood Commission entered into an emergency agreement last year with the NCRS for an emergency watershed protection grant. They should have the final design soon and the final cost estimate is \$1.8 million. Flood control is responsible for \$450,000.00 of that. They have been maintaining the river and drainage channels and retention ponds. They have been repairing flood control structures and flood damage from North of town to the Penasco. Dick Smith has come back to help as a consultant.

UPDATE - CHAVES COUNTY COOPERATIVE EXTENSION OFFICE

Presenters: Tamara Shubert, FCS/4-H Agent, and Drew Garnett, Extension Agricultural Agent Ms. Shubert stated they finished with the Fair and saw a 9% increase. The sale brought in a lot of money to support the kids. They are working with libraries and Joy Centers to provide training. Drew Garnett stated we are back to pecan weevil season, and they will be hosting workshops. Everyone that shows up learns how to build a trap. They will also set up CEUs for November.

UPDATE – MAINSTREET ROSWELL

Presenter: Barbara Gomez, Executive Director

Ms. Gomez thanked Chaves County for their help with the Alien Fest. The city is creating a task force to make the UFO Festival better and more unified. Chaves County has been great to work with. The 30th Annual Chili Cheese Festival is coming up, September 22 through 23rd. The focus will be on agriculture, farming, and the dairy industry. There will be country music on Saturday night. Please make plans to attend and thank you for allowing them to use the Chaves County Courthouse lawn.

STEVE MCCUTCHEON - EDDY COUNTY

Mr. McCutcheon stated he is seeking an appointment to Senate District 42. He is a former Eddy County Commissioner, is married, and has four children. He and his wife are in ranching and agriculture. His political mantra is "If a third of the people don't hate you, you're not doing anything". He is a strong conservative, an individual patriot, and a Republican. He has a lot of respect for Senator Scott. If he gets the appointment he will work alongside Senator Scott. If he is appointed to the seat, he will run for re-election.

LARRY SCOTT – STATE REPRESENTATIVE DISTRICT 62

Mr. Scott stated he appreciates the Freudian slip Mr. McCutcheon made, calling him Senator. The reason he is standing for this appointment is that he believes he can make a difference. He has made a difference in the House with the help of his colleagues. The reasons why he serves do not change if he is appointed for this position or would have to run for it next June. It would be his intention to seek this seat.

5. RESOLUTION R-23-040 AUTHORIZING SUSPENDING THE MINIMUM PENALTY REQUIREMENTS OF THE PROPERTY TAX CODE

Presenter: Charlotte Andrade-Gurule, Chaves County Treasurer

Resolution R-23-040 would suspend the minimum penalty requirements of the Property Tax Code; Section 7-38-050 NMSA 1978 which states "If property taxes become delinquent, a penalty of one percent of the delinquent taxes for each month or any portion of a month they remain unpaid shall be imposed, but the total penalty shall not exceed five percent of the delinquent taxes except that, when the penalty determined under the foregoing provisions of this subsection is less than five dollars (\$5.00), the penalty to be imposed shall be five dollars (\$5.00)."

Based on the exceptionally high rate of property tax collections, it is felt that a minimum \$5.00 penalty is unnecessary. The property tax collection average for the prior 10 years is 99.34 % as of June 30, 2023. Staff recommends approval.

Rita Kane Doerhoefer, very narrow, unstriped, Chicago Cubs mailbox, Mark Road

Ms. Doerhoefer stated they are looking to do things every morning at the JOY Center. Keep Chaves County Beautiful was at the Alien Fest with 60 trash cans and over 1,000 trash bags. They get to do trash for the Chili Cheese Festival. They got their grant. There are new maple trees on the Courthouse lawn along with other plants on the grounds and they also have money for youth painting materials. Commissioner Dara helps her all the time.

Ana Nieto, Chaves County Purchasing Director

Ms. Nieto stated she has made a report/register so the Commissioners can see what is going on with the Procurement Office. This will show open bids, RFPs, sole sources, emergency situations, and quotes over \$30 thousand.

Marvin Clements, 6102 Kincaid, Roswell, NM

Mr. Clements thanked the Road Department for doing a good job with the chip/seal in his area. Last year he was on the front page of the newspaper stating they were going to start passing out citations and nothing has changed. There are junk cars, motorhomes, people coming and going. People are stealing from Allsups and the police show up at his house. Nobody is enforcing the ordinances we have.

MANAGER'S COMMUNICATIONS

Mr. Williams stated it was nice to see public participation. The Alpha 5 balloon is the 5th largest balloon in the world and the biggest in the United States. It is 250 feet long and will be anchored at NMMI. The launch date is September 14th or 15th depending on the weather. He has a barn that lines up with the Airport runway and will be placing a banner to welcome The Reno Air Racing Association. The Detention Center published a video on Facebook and had over 600 views. Thousands of people are looking at going to work for our Detention Center. The video was made by the staff, in-house, and they did a good job. He thanked the Road Department for assisting with the County Fair. He thanked Stan for looking over all the contracts, and waivers, and attending hearings for the County. They have a meeting in Alamogordo with the US Forest Service to stop the potential wilderness area designations.

COMMISSIONERS' COMMUNICATIONS COMMISSIONER PERRY

Commissioner Perry stated it was a pleasure today to be part of two processes, the referendum project and the nomination for Senate seat 42. He hopes the Governor does the right thing.

COMMISSIONER TAYLOR

Commissioner Taylor stated he agrees with Commissioner Perry's comments about the referendum project and the nomination of Mr. Scott is a positive thing. We hope the Governor will listen to their recommendation. He thanked all the staff.

COMMISSIONER DANA

Commissioner Dana thanked Bill Williams for working on the referendum resolution. An old motel will hopefully be donated and turned into transitional housing and provide behavioral health services. Businesses are frustrated with the homeless population. We don't have any long-term solutions and are hoping to have a collaborative effort between the City and the County to provide some help for these people. The RARA proposal is fantastic. She hopes we will soon have the Roswell Air Races here.

COMMISSIONER EZZELL

Commissioner Ezzell echoed previous comments. He asked where things were for Mr. Clements. Mr. Williams stated Louis has been out there multiple times along with the Sheriff's Office. Commissioner Perry stated he visited with Louis last week and saw a dumpster out there and they were dismantling two mobile homes which was a result of citations that came from Louis. We all want our area to look better, and he believes the city is also putting together a committee to deal with this.

Commissioner Bilberry thanked everyone for their participation today and thanked the staff for all their hard work.
