Mr. Duran stated they are a 501C3 and do not accept any money from the Federal Government. They only receive grants and money from tournaments. They presently have 22 drivers that take veterans to any medical appointments they have. They have five vans. He estimates that 70% of the veterans they transport would not be able to go if they didn't take them. They don't charge the veterans anything. He has been doing this since 2010. Year to date they have transported 376 veterans. All the drivers are volunteers. They need three more vehicles and are requesting \$300,000.00.

UPDATE FROM THE ROSWELL CHAMBER OF COMMERCE Andrea Moore, President, C.E.O.

Ms. Moore stated they had their Chat with the County luncheon and County Manager Williams was their guest. Next week will start their Good Morning Roswell, formerly known as Mornings with the Mayor. Rita Kane Doerhoefer, very narrow, unstriped, Chicago Cubs mailbox, Mark Road

Ms. Doerhoefer is with Keep Chaves County Beautiful. They haven't gotten their grant yet. Anybody can come to them and ask for pickers, trash bags, gloves, and red rubber bands. They have the Pollination event coming up. They have been asked for the Alien Fest to make sure trash is picked up on the Courthouse lawn. She has all the community service workers and juvie helping to pick up trash. She has also asked Sheriff Mike if they could have a presence. They are also doing

the Farmer's Market. They will be doing the Chili Cheese in late September. Ray does an excellent job and leads by example with Municipal Court. She thanked Joe for two roll-offs. When the grant comes in, they sign it, they do more than just trash. She also teaches at the Boys and Girls Club. Keep Chaves County Beautiful won the President's Award with Keep America Beautiful.

Sarah McArthur, 609 Mimosa Drive, Roswell, NM

Ms. McArthur stated it's a basic principle of the establishment clause that the government is prohibited from promoting a certain religious belief. The government also cannot force an individual to enter a house of worship or profess a certain religious view. Many citizens are forced to enter a house of worship to fulfill their basic civic duty, the right to vote. She recognizes that in Chaves County we have alternatives such as absentee voting and 12 other voting convenience centers. She believes if a public building is available, it should be given priority and replace any church location. We have a location that should have replaced a church under the resolution just passed. Churches as polling locations have been known to take advantage of captive audiences. It is an honor to be chosen as a polling site. Many churches as well as one here in Roswell have been abusing their tax-exempt status by intervening in political campaigns and has specifically signaled to their congregation and the general public who they favor in a given election as well as making derogatory comments about our State political leaders. She appreciates the Commissions position; however, citizens need to be able to vote in a location free from malicious interference and undue influence. It will be her continued goal to have all polling locations removed from all houses of worship beginning with Church On The Move and within this County and across the State.

Shawn Kelly, 1033 Ivy Drive, Roswell, NM

Mr. Kelly stated he is an associate pastor at Church On The Move. He thanked the Commissioners for all the rulings they make on behalf of our County. They are very important, and they appreciate what they do. He appreciates the rulings they made today by being fair to all people including people of religious backgrounds and beliefs. They were glad to open their church facility because they are ADA-approved and very available. They are an easy spot to get to and have plenty of parking for the community. Any time they are asked to be a blessing to this community they are going to if it's in their power to do so. Our pastor would've been here today, but he is on a prayer walk around the perimeter of our State. They are available to the county in any possible way they can be.

MANAGER'S COMMUNICATIONS

Mr. Williams pointed out how great the Chaves County staff is. Jason Romero bringing home the gold and Rita isn't really staff but she is bringing home a gold award too. Our staff is amazing. Anabel was a huge help to him over the last few weeks with the issues at the jail, making a lot of tough and quick decisions. They have hired Michael Brisco as the new jail administrator. He has handled a lot of issues. The first weekend, Bill got 20 to 30 calls with issues he had to deal with at the jail and subsequent to that his grandson died. Everything was handled very well by the staff, and he thanked them.

Commissioning of the Nextera Solar expansion will be coming up. Commercial solar is different from community solar. It is managed through the utility providers. We were able to get an additional \$600,000.00 for the county throughout the life of those bonds instead of settling for the first offer they made. Aspen, W.I.N.G.S for Life and other programs are very important. During COVID they had to pull back on some of those, but they are working to get these programs back in place at CCDC. They met with the Office of the Public Defender and made some changes to make sure they have access to their clientele. The Cooperative Extension Service is happy with the willingness to purchase a new location for them. The county is required to provide them with a building to house them.

COMMISSIONERS' COMMUNICATIONS COMMISSIONER PERRY

Commissioner Perry stated he recently attended the New Mexico Association of Counties meeting in Farmington and it's nice to see, when you walk in, that Chaves County is in good shape. It's a testament to the professional presentations we saw here today. He also congratulated Sheriff Herrington on hiring two new deputies. He thanked the Road Department for doing a good job.
