Chairman Jeff Bilberry called the Indigent Hospital/Health Care Board meeting to order at 8:30 a.m.

All 5 commissioners were present.

Commissioner Jeff Billberry opened Section I: Approval of minutes.

Commissioner Dara Dana made the motion to approve the December 21, 2023, minutes. Commissioner T. Calder Ezzell Jr. seconded the motion. Motion carried 5-0.

Commission Communication:

Commissioner Dana commented that billing for La Casa looks like it has been resolved. Mr. Ortega agreed and stated that their billing is current at this time.

Commissioner Dana inquired into the claim for the Trans Aero Medevac claim. Mr. Ortega stated that we do currently have a contract with Trans Aero Medevac. We pay \$5,000.00 per claim. Commissioner Dana asked what determines air transportation. Mr. Ortega stated it is by doctor's orders and this claim was for a CCDC inmate transported to Las Cruces.

Ms. Anabel Barraza mentioned GRT for March was a total of \$1,519,811.68 for all funds. She explained the report that was provided to the Commissioners. Year to Date we have received 13.8 million which was 1 million more than fiscal year 22-23. The amount received last year was 12.7 million. Our budget variance is 8.38%. So far we are at 75% of year and at a positive variance of 26.90%.

January activity that contributed to this increase was construction projects in the amount of \$11.9 million, another impact was the online retail sales which was \$4.9 million. Ms. Barraza went over the different categories and amounts to review.

Chairman Billberry adjourned the meeting at 8:38 a.m.
