Commissioner Dana called the Indigent Hospital/Health Care Board meeting to order at 8:31 a.m.

There were 3 commissioners present, Commissioner Dara Dana, Commissioner Richard C. Taylor and Commissioner Michael Perry. Commissioner T.Calder Ezzell Jr. joined by phone. Chairman Jeff Bilberry was absent.

Commissioner Dara Dana opened with Section I: Approval of minutes

Commissioner Richard C. Taylor made the motion to approve December 15, 2022 minutes. Commissioner Michael Perry seconded the motion. Motion carried 4-0.

Section II: Presentation of Claims "A" Non-Sole Providers (approval for payment), Exhibits A & B, for a total of \$3,045.80 (19 claims).

Commissioner Dana inquired about the claims over 90 days and any updates. Mr. Ortega stated that La Casa was continuing to work on their billing issues and working with a new billing company as well as a new software system for their health records. Commissioner Dana stated that she did receive a letter from La Casa explaining their billing issues.

Ms. Anabel Barraza went over February GRT. Anabel explained that the state is dropping one half percent in GRT as of July 1st. February GRT is 22.8% more. Construction had 3.7 million dollars more in activity. The other category that had an increase was professional services.

Mr. Bill Williams mentioned that there is a legislative bill that is trying to drop professional services from being charged GRT. The County is working with New Mexico counties on this bill.

Commissioner Dara Dana adjourned the meeting at 8:38 a.m.
