Chairman William E. Cavin called the Indigent Hospital/Health Care Board meeting to order at 8:30 a.m.

There were 4 commissioners present. Commissioner Ezzell was absent.

Chairman William Cavin opened with Section I: Approval of minutes

Commissioner Dara Dana made the motion to approve the June 23,2022 minutes. Commissioner Richard Taylor seconded the motion. Motion carried 4-0.

Commissioner Dana inquired about the number of dental claims. Mr. Ortega stated dental claims are about average, overall claims this quarter have gone down. Commissioner Dana asked how much longer Carabelli Dental would be on the reports. Jeff stated this is the last one.

Anabel Barrage, CFO

Commissioner Dana asked if the report combines both Primary Care and Primary Care Dental. Jeff stated they are combined. Commissioner Dana requested a breakdown of claims for Primary Care and Primary Care Dental.

Commissioner Dana asked how the IHC fund is doing financially. Jeff stated the IHC Fund is doing well. The total cash balance is \$2.6 million and Gross Receipts have been increasing.

Lucia gave a brief presentation on gross receipt taxes. She stated gross receipts have not been received yet. Chairman Cavin asked Lucia what she anticipated the GRT would look like. Lucia stated she anticipates seeing a small increase. Chairman Cavin asked if this increase was from recreational marijuana sales that started in April. Lucia stated she won't know until the report comes out.

Commissioner Bilberry asked if we knew where the increase was from. Lucia stated we don't know what the RP500 report will look like, normally they lump everything together. Hopefully we can segregate the report so we can tell.

Chairman William Cavin adjourned the meeting at 8:38 a.m.
