MANAGER'S COMMUNICATIONS

Mr. Williams thanked Ms. Coleman for coming over from Lincoln County to support the Resolution supporting Luna County. The surrounding counties all work together towards common causes. They just got back from NACO. They may need to go to the annual convention in Florida. They have two resolutions to put forward in the Public Steering Committee. One has to do with the natural asset companies. It looks like we have \$590,000.00 in legislative money coming our way for the cooperative extension building and another \$270,000.00 for the Pecos Valley Regional Communications Center. He thanked the Detention Facility and all the work they have done and continue to do. He will be speaking on the radio tomorrow at 8:00 am and he does a Chat with Chaves County at the Chamber of Commerce on the first Wednesday of each month. He will be speaking at Republican Woman next Wednesday along with Chad Cole from the City.

COMMISSIONERS' COMMUNICATIONS COMMISSIONER PERRY

Commissioner Perry was happy to get home from Washington. He thanked Bill for everything he's done to support Luna County. We don't have a lot of support from our Federally elected officials in New Mexico. They are creating obstacles for us to overcome. It's nice to see County Commissioners support these issues. It's good news that our PILT funding is occurring and secure rural schools. It's nice to have good weather in front of us.

COMMISSIONER TAYLOR

Commissioner Taylor stated the EDC has done a fantastic job and he appreciated the proclamation. The cooperation between the City and County and all other agencies is great and this is how we accomplish things. He congratulated the Finance and Treasurer's Office for the clean audit. There is a lot of work that goes into making sure we qualify. If they make a ruling, they need to hold people to it.

COMMISSIONER DANA

Commissioner Dana thanked Anabel and all the Departments. She hears horror stories being on the New Mexico Counties Board and we don't have those problems. She gave an update on an email she received about legislation and money received. New Mexico Counties is a great lobbying organization for all of us and they stand up for all 33 Counties. There was a bill to shut down detention centers. Senator Ortiz y Pino showed up to the meeting and listened to the people who spoke, and that bill was killed. In March we will have a legislative update. This is an election year, and we need people who will stand up and fight for us.

Commissioner Ezzell apologized for not being in person. He thanked the IT Department for being able to watch the meeting on Facebook. He congratulated Anabel and her staff.

COMMISSIONER BILBERRY

Commissioner Bilberry thanked everyone for being here today and thanked Lori for making the trip over from Luna County. He appreciates everyone's hard work.
