#### Chaves Soil and Water Conservation District - Jennifer Pierce

They have partnered with the Extension Office to conduct a grant writing training on August 13<sup>th</sup> from noon to six at the Civic Center and lunch will be provided. They are doing a project west of town comparing bell grazing with contour plowing, broadcast seeding, and fertilization. They got a grant funded for this.

#### Chaves County Flood Superintendent Brian Houghtalin

We have been getting some rain and flooding but it's not due to any failure of any flood control structures. It's just severe rain. Monday evening we had some flooding in the Base area and it will take a little while for that to drain. Ninety percent of the debris coming from Ruidoso is stopped at Two Rivers. They've had flows in the Rocky Arroyo and the Hondo. The Berrendo had a little bit of flooding from water crossings two weeks ago. No significant damage just some road closures

#### Roswell-Chaves County Economic Development Corporation - Mike Espiritu

Mr. Espiritu gave an update on the Roswell Air Races and stated in May 2025 the pilots will come in to get certified. He went to Santa Fe to meet with officials about their continued support and funding for infrastructure needs. An update was given on BiltWise, the manufacturer company has folks from South Carolina here for training and are already working on several homes. The EDC was recertified as an agency. The EDC annual report was presented. They held a Gala last Thursday with over 360 people in attendance.

The Sheriff introduced his new deputies. He has six deputies that will attend the academy. He is proud of how many people want to do this job and their heart is in it. They want to serve and protect their community. He also introduced his two new school resource officers.
