## AMENDING THE DEDICATION OF A COUNTY LOCAL OPTION GROSS RECEIPTS TAX

BE IT ORDAINED BY THE GOVERNING BODY OF CHAVES COUNTY, NEW MEXICO that Section 4 of Ordinance Number 0-089, effective July 1, 2015, and imposing an excise tax equal to one-eighth of one percent (.125%) of gross receipts tax is amended to read:

**Section 4. Dedication.** Revenue from the county hold harmless gross receipts tax will be used for Chaves County Detention Center construction and operations, Chaves County Road Department, reimbursement of depleted funds used to construct Detention Center, and securing revenue bonds.

The effective date of this amendment shall be July 1, 2015 or January 1, 2016, whichever date occurs first after the expiration of at least three months from the date this ordinance is delivered or mailed to the Taxation and Revenue Department.

### ORDINANCE NUMBER O-090

## AMENDING THE DEDICATION OF A COUNTY LOCAL OPTION GROSS RECEIPTS TAX

## AMENDING THE DEDICATION OF A COUNTY LOCAL OPTION GROSS RECEIPTS TAX

BE IT ORDAINED BY THE GOVERNING BODY OF CHAVES COUNTY, NEW MEXICO that Section 4 of Ordinance Number 0-091, effective July 1, 2015, and imposing an excise tax equal to one-eighth of one percent (.125%) of gross receipts tax is amended to read:

### ORDINANCE NO. 0-094

PLEDGING CHAVES COUNTY, NEW MEXICO HOLD HARMLESS GROSS RECEIPTS TAX REVENUES AS SECURITY FOR CHAVES COUNTY, NEW MEXICO GROSS RECEIPTS TAX REVENUE BONDS, SERIES 2007, CHAVES COUNTY LOAN AGREEMENT DATED JUNE 13, 2013, AND CHAVES COUNTY PROMISSORY NOTE DATED JANUARY 13, 2015.

WHEREAS, the Board of County Commissioners (the "Board") of Chaves County, New Mexico (the "County") has previously authorized, issued, and has outstanding the County's Gross Receipts Tax Revenue Bonds, Series 2007, Chaves County Loan Agreement dated June 13, 2013, and Chaves County Promissory Note dated January 13, 2015 (collectively, the "Revenue Bonds"); and

WHEREAS, the ordinances and resolutions authorizing issuance of the Revenue Bonds all contain covenants to maintain the pledged gross receipts tax revenues (the "Pledged Revenues"); and

WHEREAS, the State of New Mexico (the "State") has amended Section 7-1-6.47, NMSA 1978 (the "State Distribution") to decrease the amount of revenues distributed to the County; and

WHEREAS, the decrease in the State Distribution adversely affects the Pledged Revenues and the Revenue Bonds; and

WHEREAS, pursuant to Section 7-20E-28, NMSA 1978, the County has enacted three-eighths of the Hold Harmless Gross Receipts Tax.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF CHAVES COUNTY, NEW MEXICO:

- Section 1. Lien on Pledged Revenues. The County's Hold Harmless Gross Receipts Tax Revenues are hereby authorized to be pledged to, and are hereby pledged, and the County grants a security interest therein for the payment of the principal of, premium, if any, and interest on the Revenue Bonds:
- Section 2. Ordinance Irrepealable. This Ordinance shall be and remain irrepealable until the Revenue Bonds and the interest thereon shall be fully paid, canceled and discharged, or there has been defeasance of the Revenue Bonds.
- Section 3. Severability Clause. If any section, paragraph, clause or provision of this Ordinance shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this Ordinance.

Section 4. Repealer Clause. All bylaws, orders, resolutions and ordinances, or parts thereof, inconsistent herewith are hereby repealed to the extent only of such inconsistency. This repealer shall not be construed to revive any bylaw, order, resolution or ordinance, or part thereof, heretofore repealed.

Section 5. Effective Date. An emergency is hereby declared in order to preserve the health, welfare, and economy of the County and it is therefore necessary that this Ordinance became effective immediately upon filing with the County Clerk.
