

Findings of Fact listed in the Staff Review. There is written objection that could trigger a supermajority vote of four (4) Commissioners, though the proposed Conditions of Approval seem to have mitigated that requirement based upon the P&Z Commission meeting.

The Regular Meeting of the Chaves County Planning & Zoning Commission was held in the Commission Chambers at the Chaves County Administrative Center on November 7, 2017 beginning at 5:30PM.

Minutes

The minutes of the October 3, 2017 meeting were approved unanimously as submitted.

New Business

1. Z 2017-16

Request for a Special Use Permit to allow a non-profit cemetery on property described as S34 T14S R26E S2 SW4 SW4 E990', parcel # 4148085088500, address being 613 Jicarilla Rd., Hagerman

Mr. Johnson began the Staff Report by stating that the subject property at 613 Jicarilla Road was 15 acres in size. This request was for a Special Use Permit to allow a non-profit cemetery. The proposed focus of the burial area is the hill in the north center of the property. There are several graves on the property at this point in time.

There are a few residences in the vicinity, the nearest being five hundred feet from the subject property and almost a thousand feet from the "hill". All surrounding property is zoned Agricultural or Ag-Residential. The Old Dexter Highway is just over a mile to the west, so access is good. There is an industrial facility located on the east side of the property. There is no surface water in the vicinity and groundwater does not appear to be an issue as the well depth is over hundred feet (100') to groundwater. Consideration of a Special Use Permit seems to make sense in this location.

No objections have been received from County Departments or from other agencies. The New Mexico Environment Department has noted that the Environmental Health Bureau does not have anything specific to this type of property.

There is written objection from a neighboring landowner that may trigger a supermajority vote by the Board of Commissioners, but proposed conditions of approval may negate said objections and concerns.

It is possible for this type of use to fit a given neighborhood. It is also possible that conditions that might be acceptable for the facility might be compatible with conditions that might be acceptable to the neighborhood and/or the County.

There may be a sign proposed. Hours of operation do not seem relevant. Screening, security, dust control and other potential issues can be re-considered in the future as the proposed use develops.

Because of the relatively minor impact, Staff recommends approval of this Special Use Permit to allow a non-profit cemetery with the following conditions:

- 1.) That no miscellaneous junk or derelict vehicles be stored outside the compound area where the home and accessory structure are located;
- 2.) That a cemetery sign up to six (6) square feet be allowed;
- 3.) That the facility be in compliance with all State regulations;
- 4.) That the burial area be a minimum of two hundred feet (200') from all property lines and on the south facing slope of the property (These appear to be similar setbacks from the north property line.);
- 5.) That the internment boundaries be accurately defined and marked on the property:
- 6.) That said internment area be a maximum of one half (1/2) acre;
- 7.) That any approval and the defined internment zone be filed with the Office of the County Clerk for posterity;
- 8.) That any lighting used in conjunction with this use be shielded from surrounding existing and future residential uses and be night sky sensitive, and
- 9.) That this Special Use be reviewed administratively in two (2) years or ten additional (10) burials, whichever comes first, and only brought back to the Commission on an as needed base or when the need exceeds the proposed half (1/2) acre;

Findings of Fact could include: the proposed use will have minimal impact as far as noise and additional traffic; there are few homes in the vicinity; there is an industrial business use adjacent to the property; proposed restrictions will limit impact on neighboring properties

This office is not aware of any complaints regarding this use in the last 8 years. No objections have been received from County Departments or other agencies. However, the County Assessor's Office has requested that a stipulation be added to cover any concerns they may have.

Chair Rogers asked if the applicant was present.

Audrey Whitten introduced herself and stated her address of 613 Jicarilla Rd. She stated that so far, only family members are buried on the property and that they have been cremated. They do not foresee any trespass issues and have cleared the property for easy access.

Commissioner Salas asked how many family members were buried at the property and how long have they been there. Mrs. Whitten responded that there are currently 4 family members buried and that the first one was buried in 2011 and the latest one in October 2017.

Commissioner Salas then asked about the activity level at the cemetery. Mrs. Whitten stated that the cemetery was consecrated in 2014 and that there is very limited activity unless there is a burial.

Commissioner Salas wanted to know if the burial place was fenced off. Mrs. Whitten commented that they plan to fence it off eventually along with a gravel driveway up to the burial site. She also stated that for security purposes, they will limit the access to visitors and they don't plan to have it open 24/7.

Commissioner Salas asked if there was a stipulation that all bodies buried there must be cremated. Mrs. Whitten responded that there is not but it has worked out well that way. They believe in green burials meaning burial within 24 hours after death unless there is an arrangement with a funeral home which would include refrigeration.

Commissioner Salas wanted to know how many bodies would actually fit in that ½ acre plot. Mrs. Whitten responded that it would be much more than what is stipulated by the County.

Commissioner White asked if the cemetery would be available to the public. Mrs. Whitten responded that it would be open to the public and that is the reason for it being non-profit.

Chair Rogers asked if anyone wished to speak for or against the application.

Joe Steed introduced himself and stated his address at 8079 Wichita Rd. Hagerman. His concern was having to look at a cemetery every time he walks out his front door and as he drives in and out of his property. He would like for them to move it over to the south side of the hill.

Chair Rogers asked Mr. Steed if he sees any of the crosses out there now. Mr. Steed responded that he does not right now but is not sure what will happen in 6 months or 1 year.

Commissioner Salas asked Mr. Steed how far away his home was from the burial site. Mr. Steed calculated the distance to be about ¼ mile from his home.

Commissioner Salas then asked Mrs. Whitten if it would be possible to add some vegetation barrier, for example Arizona cypress or trees. Mrs. Whitten was fine with adding some type of barrier and did mention that most of the cemetery was on the south side of the hill.

Commissioner Wagner made a motion to recommend approval of Case Z 2017-16 including the Conditions of Approval and Findings of Fact. Commissioner Salas seconded the motion. Motion carried by a 4-0 vote.





STAFF REVIEW Z 2017-16

The subject property at 613 Jicarilla Road is 15 acres in size. This request is for a Special Use Permit to allow a non-profit cemetery. The proposed focus of the burial area is the hill in the north center of the property. There are several graves on the property at this point in time.

There are a few residences in the vicinity, the nearest being five hundred feet from the subject property and almost a thousand feet from the "hill". All surrounding property is zoned Agricultural or Ag-Residential. The Old Dexter Highway is just over a mile to the west, so access is good. The first recipient was interred in June of 2011, with three other family members being added since.

Our purpose is to provide resting places for people that have no funds for purchasing a burial plot, free of charge, such as elderly persons on retirement.

The small compound on the property is reserved for caretakers, although perpetual care isn't part of our program. We have made arrangements for the crosses to be maintained by Crosses Across America Organization.

Fencing and gravel are planned for as can be financially afforded, donations will be gratefully accepted. We have also been engraving head stones ourselves from sand stone if requested, until we have passed on ourselves.







LEASE AGREEMENT A-17-030 BETWEEN CHAVES COUNTY AND DIANNE S. MEDA FOR LEASE OF OFFICE BUILDING

THIS AGREEMENT is made this 1st day of November, 2017, by and between the County of Chaves, a political subdivision of the State of New Mexico, herein referred to as "Lessor" and Dianne S. Meda, hereinafter referred to as "Lessee."

WHEREAS, Lessor is the owner of certain property located in Roswell, New Mexico, known as the Pecos Valley Medical Complex, which is located at 1600 SE Main, Roswell, New Mexico, in which are located certain office suites and spaces; and

WHEREAS, Lessor desires to lease to Lessee, and Lessee desires to lease from Lessor the office space, which is approximately 230 square feet, constituting a portion of the building identified as Suite D-2 Office 1, (the "Premises"), upon the terms and conditions set forth herein.

NOW THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and in further consideration of the covenants and agreements set forth herein, the parties do hereby agree as follows:

- 1. <u>LEASE</u>. Lessor does hereby lease to Lessee and Lessee hereby leases from Lessor the Premises.
- 2. <u>TERM</u>. The primary term of this Lease begins November 1, 2017 and runs for a period of seven months ending June 30, 2018. This Agreement shall automatically renew for up to three (3) additional one (1) year periods, not to exceed a total of four (4) years, unless terminated in accordance with the terms provided herein.
- 3. <u>TERMINATION</u>. Either party may terminate this Agreement, with or without cause, by giving the other party sixty (60) days written notice of such intention to terminate.
- 4. RENT. The lease amount shall be paid in monthly installments of Two Hundred Dollars (\$200.00), which sum shall be paid on the first day of each month during the term of this Lease. Lessee may prepay any installment or installments of rent at any time provided, however, that such prepayment shall not be in excess of six (6) months annual rental without the prior written consent of Lessor. All rentals required by the terms of this Lease shall be paid in lawful money of the United States or by check or draft of the Lessee, or someone acting for the Lessee, redeemable in lawful money of the United States, and shall be paid to Chaves County Treasurer, PO Box 1772, Roswell, NM 88202-1772 (check shall reference property).
- 5. <u>USE OF PREMISES</u>. Lessee covenants and agrees that it will use and occupy the Premises only as an office or for related support activities, and for no other purpose without having first obtained the written consent of the Lessor. In the event

Lessee fails to utilize and occupy the Premises as an office or for activities reasonably related thereto without having first obtained the written consent of Lessor, Lessor shall have the option to terminate this Lease, and to re-enter the Premises as hereinafter set forth. Lessee, at its expense, shall conform with and comply with all applicable regulations, ordinances and laws relating to the use and occupancy of the Premises.

- 6. <u>WASTE, NUISANCE OR UNLAWFUL ACTIVITY</u>. Lessee shall not allow waste or nuisance on the Premises, or use or allow the Premises to be used for any unlawful activity. Lessee shall see that all persons coming on to the Premises shall use the Premises in an orderly courteous, and safe manner, with due regard of the rights of others who may be using the Premises.
- 7. <u>UTILITIES</u>. Lessor shall pay for the following utilities serving the Premises during the term of this Lease: electricity, gas, water, telephone and internet. All payments shall be made by the Lessor directly to the utility company furnishing such service.
- 8. <u>REPAIRS AND MAINTENANCE</u>. During the term of this Lease and all renewals thereof, Lessee shall make, at its own expense, all repairs needed to maintain the Premises in good condition and repair, including such repairs, alterations and maintenance as may be necessary to impede normal wear and tear, or as may be necessary in order that the Premises, including the improvement or fixtures thereon, shall conform to the lawful requirements, laws, ordinances, directions of proper public authorities, except those repairs and maintenance which are the responsibility of Lessor.

Lessor will be responsible for outside of the building, roof, glass, lawn, cooling and heating systems, electrical, plumbing, grounds, landscaping, parking lot, external doors, outdoor security lighting, sprinkler system, and will reasonably maintain the same.

9. <u>LIABILITY OF LESSEE</u>. Lessee agrees to defend, indemnify and save Lessor harmless against any and all loss, damage, claim or expense arising out of the use of the Premises by Lessee, its agents, employee, invitee or trespassers, or out of any accident or other occurrence arising out of the use of the Premises, causing injury to any person whomsoever, or property whatsoever, due directly or indirectly to the use of the Premises or any part thereof by Lessee, its agents, employees, customers, patrons or other persons using the leased Premises.

Lessor shall not be liable to Lessee or any person for any damage or injury arising out of the use of the Premises by Lessee to any person or property occasioned by Lessee's use. Lessee agrees and covenants to defend, indemnify and save harmless Lessor from all such liability and expense in connection with Lessee's use of the Premises.

10. <u>LESSOR'S ACCESS TO THE PREMISES</u>. Lessor, its agents or employees, shall have the right to enter the Premises during normal business hours to

inspect said Premises. Notwithstanding anything contained herein, Lessor shall have no duty whatsoever to make any inspection, and lessor shall not be held liable for any failure to discover, observe, or remedy any defects on or about the Premises. Lessor shall inspect the Premises with Lessee at the beginning of this Lease.

- 11. <u>DAMAGE OR DESTRUCTION</u>. In the event the Premises, or any portion thereof, is damaged or destroyed by any cause whatsoever, including but not limited to acts of God, this Lease shall terminate.
- 12. <u>ASSIGNMENTS, LEASES AND SUBLEASES</u>. Lessee shall not assign any interest under the terms of this Lease without the prior written consent of Lessor first being obtained. Before any assignment of the Lease shall become effective, the assignee shall in writing assume and agree to be bound by all the covenants, agreements, terms and conditions of this Lease.

No assignment, sublease, or transfer of interest in whole or in part made by Lessee or any subsequent assignee or transferee in interest shall operate to discharge or abate any obligation hereunder made or hereafter assumed by Lessee or any assignee or sublessee or transferee.

A consent by Lessor to one assignment shall in no event be a consent to a subsequent assignment, sublease, or occupation by other persons.

Any unauthorized assignment or sublease shall, at the option of Lessor, be void and shall terminate the Lease.

- 13. <u>SURRENDER</u>. Lessee covenants and agrees to deliver up and surrender possession of the Premises to Lessor at the termination of this lease, by expiration of the term or otherwise, in as good condition and repair as the same shall be at the commencement of this lease, and in as good condition and repair as shall be required of Lessee during the term hereof, excepting only natural wear and decay which cannot reasonably be arrested by regular repair and maintenance.
- 14. OWNERSHIP OF BUILDING, STRUCTURES AND OTHER IMPROVEMENTS. All buildings, structures, installations and other permanent structural improvements presently existing or which may hereafter be erected or placed upon the Premises, whether by Lessor or Lessee, shall be and remain the property of Lessor, and Lessor shall derive all benefits of such ownership, including all benefits accruing to Lessor by law from depreciation thereof.
- 15. <u>SUMS DUE LESSOR A LIEN</u>. Subject to the other provision contained in this Lease Agreement, all sums which shall become due to Lessor on account of any provision whatsoever of this lease are and shall always constitute a valid lien upon any

and all goods, chattels and other property belonging to the Lessee and located upon he Premises.

- 16. NOTICES. Any notice provided for herein shall be sufficiently given if served personally or if deposited in the United States mail, postage prepaid, certified mail, return receipt requested, addressed to the party to whom the notice is to be served. If either the Lessor or Lessee shall at any time change its name, or if there be an assignment or other disposition of lease rights by either party, of if either party changes the place of address to which such notice or communication shall be sent, written notice of such communication shall be given to the other party. Until further notice in writing is served, any notice or communication with reference to this Lease Agreement addressed to Lessor may be addressed to the Chaves County Manager, PO Box 1817, Roswell, NM 88202-1817, and any such notices or communication addressed to Lessee may be addressed to Dianne S. Meda, 1600 SE Main, Suite D-2, Roswell, NM 88203. Notices given as provided herein shall be deemed effectively given as of the date of personal delivery or as of the third business day following the date of deposit of same for mailing in the United States Post Office.
- 17. <u>COVENANTS RUN TO SUCCESSORS, ASSIGNS, ETC</u>. It is agreed that all covenants, conditions, agreements and undertakings in this lease shall extend to and be binding upon the parties hereto, and their heirs, successors, personal representatives and assigns.
- 18. <u>ENTIRE AGREEMENT</u>. The parties hereto agree that this Lease incorporates all of the agreements, covenants and understandings between the parties hereto concerning the subject matter hereof, and that all covenants, agreements and understandings have been merged into this Lease. No prior agreements or understandings, verbal or otherwise, of the parties or their agents shall be valid or enforceable.
- 19. <u>INVALIDITY OF PARTICULAR PROVISIONS</u>. If any term or provision of this Lease or the application thereof to any person or circumstances shall be held invalid or unenforceable, the remainder of this Lease or the application of such term or provision to other persons or circumstances other than those to which it is held invalid or unenforceable shall not be affected thereby. Each term and provision of this Lease shall be valid and enforceable to the fullest extent permitted by law.

LEASE AGREEMENT A-17-031 BETWEEN CHAVES COUNTY AND DIANE TAYLOR FOR LEASE OF OFFICE BUILDING

THIS AGREEMENT is made this 1st day of November, 2017, by and between the County of Chaves, a political subdivision of the State of New Mexico, herein referred to as "Lessor" and Diane Taylor, hereinafter referred to as "Lessee."

WHEREAS, Lessor is the owner of certain property located in Roswell, New Mexico, known as the Pecos Valley Medical Complex, which is located at 1600 SE Main, Roswell, New Mexico, in which are located certain office suites and spaces; and

WHEREAS, Lessor desires to lease to Lessee, and Lessee desires to lease from Lessor the office space, which is approximately 230 square feet, constituting a portion of the building identified as Suite D-2 Office 2, (the "Premises"), upon the terms and conditions set forth herein.

NOW THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and in further consideration of the covenants and agreements set forth herein, the parties do hereby agree as follows:

- 1. <u>LEASE</u>. Lessor does hereby lease to Lessee and Lessee hereby leases from Lessor the Premises.
- 2. <u>TERM.</u> The primary term of this Lease begins November 1, 2017 and runs for a period of seven months ending June 30, 2018. This Agreement shall automatically renew for up to three (3) additional one (1) year periods, not to exceed a total of four (4) years, unless terminated in accordance with the terms provided herein.
- 3. <u>TERMINATION</u>. Either party may terminate this Agreement, with or without cause, by giving the other party sixty (60) days written notice of such intention to terminate.
- 4. <u>RENT</u>. The lease amount shall be paid in monthly installments of Two Hundred Dollars (\$200.00), which sum shall be paid on the first day of each month during the term of this Lease. Lessee may prepay any installment or installments of rent at any time provided, however, that such prepayment shall not be in excess of six (6) months annual rental without the prior written consent of Lessor. All rentals required by the terms of this Lease shall be paid in lawful money of the United States or by check or draft of the Lessee, or someone acting for the Lessee, redeemable in lawful money of the United States, and shall be paid to Chaves County Treasurer, PO Box 1772, Roswell, NM 88202-1772 (check shall reference property).
- 5. <u>USE OF PREMISES</u>. Lessee covenants and agrees that it will use and occupy the Premises only as an office or for related support activities, and for no other purpose without having first obtained the written consent of the Lessor. In the event

Lessee fails to utilize and occupy the Premises as an office or for activities reasonably related thereto without having first obtained the written consent of Lessor, Lessor shall have the option to terminate this Lease, and to re-enter the Premises as hereinafter set forth. Lessee, at its expense, shall conform with and comply with all applicable regulations, ordinances and laws relating to the use and occupancy of the Premises.

- 6. <u>WASTE, NUISANCE OR UNLAWFUL ACTIVITY</u>. Lessee shall not allow waste or nuisance on the Premises, or use or allow the Premises to be used for any unlawful activity. Lessee shall see that all persons coming on to the Premises shall use the Premises in an orderly courteous, and safe manner, with due regard of the rights of others who may be using the Premises.
- 7. <u>UTILITIES</u>. Lessor shall pay for the following utilities serving the Premises during the term of this Lease: electricity, gas, water, telephone and internet. All payments shall be made by the Lessor directly to the utility company furnishing such service.
- 8. <u>REPAIRS AND MAINTENANCE</u>. During the term of this Lease and all renewals thereof, Lessee shall make, at its own expense, all repairs needed to maintain the Premises in good condition and repair, including such repairs, alterations and maintenance as may be necessary to impede normal wear and tear, or as may be necessary in order that the Premises, including the improvement or fixtures thereon, shall conform to the lawful requirements, laws, ordinances, directions of proper public authorities, except those repairs and maintenance which are the responsibility of Lessor.

Lessor will be responsible for outside of the building, roof, glass, lawn, cooling and heating systems, electrical, plumbing, grounds, landscaping, parking lot, external doors, outdoor security lighting, sprinkler system, and will reasonably maintain the same.

9. <u>LIABILITY OF LESSEE</u>. Lessee agrees to defend, indemnify and save Lessor harmless against any and all loss, damage, claim or expense arising out of the use of the Premises by Lessee, its agents, employee, invitee or trespassers, or out of any accident or other occurrence arising out of the use of the Premises, causing injury to any person whomsoever, or property whatsoever, due directly or indirectly to the use of the Premises or any part thereof by Lessee, its agents, employees, customers, patrons or other persons using the leased Premises.

Lessor shall not be liable to Lessee or any person for any damage or injury arising out of the use of the Premises by Lessee to any person or property occasioned by Lessee's use. Lessee agrees and covenants to defend, indemnify and save harmless Lessor from all such liability and expense in connection with Lessee's use of the Premises.

10. <u>LESSOR'S ACCESS TO THE PREMISES</u>. Lessor, its agents or employees, shall have the right to enter the Premises during normal business hours to

inspect said Premises. Notwithstanding anything contained herein, Lessor shall have no duty whatsoever to make any inspection, and lessor shall not be held liable for any failure to discover, observe, or remedy any defects on or about the Premises. Lessor shall inspect the Premises with Lessee at the beginning of this Lease.

- 11. <u>DAMAGE OR DESTRUCTION</u>. In the event the Premises, or any portion thereof, is damaged or destroyed by any cause whatsoever, including but not limited to acts of God, this Lease shall terminate.
- 12. <u>ASSIGNMENTS, LEASES AND SUBLEASES</u>. Lessee shall not assign any interest under the terms of this Lease without the prior written consent of Lessor first being obtained. Before any assignment of the Lease shall become effective, the assignee shall in writing assume and agree to be bound by all the covenants, agreements, terms and conditions of this Lease.

No assignment, sublease, or transfer of interest in whole or in part made by Lessee or any subsequent assignee or transferee in interest shall operate to discharge or abate any obligation hereunder made or hereafter assumed by Lessee or any assignee or sublessee or transferee.

A consent by Lessor to one assignment shall in no event be a consent to a subsequent assignment, sublease, or occupation by other persons.

Any unauthorized assignment or sublease shall, at the option of Lessor, be void and shall terminate the Lease.

- 13. <u>SURRENDER</u>. Lessee covenants and agrees to deliver up and surrender possession of the Premises to Lessor at the termination of this lease, by expiration of the term or otherwise, in as good condition and repair as the same shall be at the commencement of this lease, and in as good condition and repair as shall be required of Lessee during the term hereof, excepting only natural wear and decay which cannot reasonably be arrested by regular repair and maintenance.
- 14. OWNERSHIP OF BUILDING, STRUCTURES AND OTHER IMPROVEMENTS. All buildings, structures, installations and other permanent structural improvements presently existing or which may hereafter be erected or placed upon the Premises, whether by Lessor or Lessee, shall be and remain the property of Lessor, and Lessor shall derive all benefits of such ownership, including all benefits accruing to Lessor by law from depreciation thereof.
- 15. <u>SUMS DUE LESSOR A LIEN</u>. Subject to the other provision contained in this Lease Agreement, all sums which shall become due to Lessor on account of any provision whatsoever of this lease are and shall always constitute a valid lien upon any

and all goods, chattels and other property belonging to the Lessee and located upon he Premises.

- 16. NOTICES. Any notice provided for herein shall be sufficiently given if served personally or if deposited in the United States mail, postage prepaid, certified mail, return receipt requested, addressed to the party to whom the notice is to be served. If either the Lessor or Lessee shall at any time change its name, or if there be an assignment or other disposition of lease rights by either party, of if either party changes the place of address to which such notice or communication shall be sent, written notice of such communication shall be given to the other party. Until further notice in writing is served, any notice or communication with reference to this Lease Agreement addressed to Lessor may be addressed to the Chaves County Manager, PO Box 1817, Roswell, NM 88202-1817, and any such notices or communication addressed to Lessee may be addressed to Diane Taylor, 1600 SE Main, Suite D-2, Roswell, NM 88203. Notices given as provided herein shall be deemed effectively given as of the date of personal delivery or as of the third business day following the date of deposit of same for mailing in the United States Post Office.
- 17. <u>COVENANTS RUN TO SUCCESSORS, ASSIGNS, ETC</u>. It is agreed that all covenants, conditions, agreements and undertakings in this lease shall extend to and be binding upon the parties hereto, and their heirs, successors, personal representatives and assigns.
- 18. <u>ENTIRE AGREEMENT</u>. 
