FEBRUARY 8, 2019

The Board of Chaves County Commissioners held a Special Commission Meeting in the Commission Chamber of the Joe Skeen Building, #1 St. Mary's Place in Roswell, New Mexico. Chairman Cavin called the meeting to order at 2:00p.m. Commissioner Corn led the Pledge of Allegiance and Commissioner Dana led in prayer. Those present were Commissioners Corn, Cavin and Dana. Commissioner Bilberry and Ezzell were absent. Also present were County Manager Stan Riggs, Public Services Director Bill Williams, Sheriff Mike Herrington, Superintendent McIlroy, County Clerk Dave Kunko, news media, staff and guests.

2019 SPECIAL ELECTION CANVASS

Mr. Kunko thanked his staff for all the work they put into this election and how well they handled their first all-mail Special Election. He compared the turnout of this all-mail Special Election with the turnout in RISD and Hagerman Schools elections in 2015 and 2017. In this 2019 Election the turnout for RISD was 22% while the Hagerman Schools turnout was 20%. RISD was 7% in 2015 and also 7% in 2017. Hagerman was 9% in a special election in 2016 and 18% in 2017. Mr. Kunko stated the all-mail election did produce a higher turnout, however he expected many more returned ballots.

ROSWELL INDEPENDENT SCHOOL DISTRICT

Commissioner Corn moved to approve the results for the General Obligation Bond with 4,311 ballots cast in favor of the bond and 1,822 ballots cast against the bond. His motion was also for the approval of the results for the Capital Improvements Tax with 3,996 ballots cast in favor of the tax and 2,194 ballots cast against the tax. Commissioner Dana seconded the motion. A voice vote was unanimous, and the motion carried.

HAGERMAN MUNICIPAL SCHOOL DISTRICT

Commissioner Corn moved to approve the results for the Capital Improvements Tax with 134 ballots cast in favor of the tax and 75 ballots cast against the tax. Commissioner Dana seconded the motion. A voice vote was unanimous, and the motion carried.

TATUM MUNICIPAL SCHOOL DISTRICT

Commissioner Corn moved to approve the results for the Capital Improvements Tax with 0 ballots cast in favor of the tax and 0 ballots cast against the tax. Commissioner Dana seconded the motion. A voice vote was unanimous, and the motion carried.

Commissioner Dana commended Superintendent McIlroy on her engagement with the community and the school district's effort in school improvement.

Superintendent McIlroy thank the Commission for all their support and looked forward to further work with the Commission and community. The Canvass was adjourned at 2:25p.m.
