PROCLAMATION

Commissioner Cavin stated an executive decision was made to save this for the New Year. The proclamation has to do with the economic development and the Air Center.

UPDATE ON THE ECONOMIC DEVELOPMENT CORPORATION

Presenter: Mike Espiritu, President

Mike Espiritu stated he attended the City Council meeting last night in Hagerman and visited with the Councilors. They are trying to find solutions and work through some areas of concern they have. They have some challenges, and the EDC will continue to help them. The EDC is very involved in education and has spent a lot of time meeting with the Superintendents in the Valley to find ways to gets kids on a successful path when they leave high school. They've also begun working with NMMI to share and coach young people on what opportunities are out there.

They spend a lot of time in business retention and expansion with visits to local businesses. Their goal is to visit forty businesses a month. The biggest challenge they are seeing is with supply chain shortages. The revolving opportunity fund was seeded by the City, and they are getting ready to roll it out. It's a low interest loan to local businesses that may need help. The EDC is not trying to be a banker, but they are trying to help small businesses. They are about to push out a general mechanical certification program at ENMU-R. A lot of businesses need people with mechanical skills and now there will be a certification program that will combine several programs and give a certification to those people.

Mr. Espiritu stated that Tim Jennings did something he thought was remarkable. His efforts in leading the way towards accessing some funds for the Air Center in Chaves County and to help bring it to the place we need it to continue to grow to, was astounding. The five million dollars that he campaigned for through the Commission and the capital outlay program and received that money for infrastructure improvements at the Air Center, was significant. Two million dollars of that is going to a water line, which is desperately needed and will also serve some residents of our County off Y O Road, but more importantly, he set the stage for us when we brought in Ascent Aviation into Chaves County. That's a big deal. 360 jobs over a few years and he believes the portfolio will continue to grow here in this area. This will bring in more jobs, more opportunities, and more things to our county. He asked Mr. Jennings to speak and share in his words what they are trying to do now and what the next steps are.

Mr. Jennings stated if we sit back, we lose, we must continue with economic development. He thanked the Commissioners for having the courage to ask for something to make our community better. He met with the Governor when he went to Santa Fe for the redistricting hearings and explained to her the value of trying to get another ten million dollars for the Air Center which is the greatest economic opportunity we have. It wasn't very long ago that we had fifty dairies in Chaves County and today we have 23. Think what happens when we're stagnant? He was glad he was asked to join the economic development group because they are people that look ahead. He is going to go back and see the Governor before the session, and he asked that the Commission send a representative because we can move Roswell forward. There are a lot of things we can do.

Mr. Espiritu stated it's a pleasure to serve this county and he appreciates the partnership they have together.

4. RESOLUTION R-21-055 - APPROVAL OF CHAVES COUNTY REDISTRICTING PLAN

Presenter: Bill Williams, Chaves County Manager

Mr. Williams stated that Chaves County is required to evaluate commission districts every ten years after the completion of the census. On November 9, 2021, four potential redistricting plans were presented and discussed at a public hearing which included public involvement and discussion. A fifth plan was requested from New Mexico Demographic Reporting to provide one additional option. The fifth plan, Plan E, was presented and discussed at a public hearing on November 18, 2021. Plans B and D were removed from consideration leaving plans A, C, and E. The Board now needs to decide on which plan they will adopt.

Further discussion from the Commission.

Commissioner Cavin stated there was discussion at the last meeting about what our current districts are and discussion that by moving one precinct we could pretty much leave things as they are. Commissioner Ezzell stated they asked the demographer to give them this information on paper and to his knowledge they haven't received this. Commissioner Ezzell and Commissioner Bilberry met with Mr. Adair last Friday and asked him what would have to be done to the current map to make it compliant, under the five percent deviation. Mr. Adair told them that moving precinct 5 from Commission district 3 to Commission district 1 and leaving everything else the same would comply with all the statutory requirements.

Commissioner Cavin stated that with presenting a new map they would need to open the floor for discussion.

PUBLIC COMMENTS:

Rita Kane Doerhoefer, very narrow unstriped Mark Road

Ms. Doerhoefer stated her only concern is that she doesn't know where district 5 is. She doesn't have a map and it's not online, she checked at 4:30 this morning. She clarified its precinct 5 and she has no idea where it is and asked if they could vote on it without putting out for public knowledge.

Stan Riggs stated this would be an amendment to an existing plan so they would be allowed to vote.

Ms. Doerhoefer asked where she would find the new map. Commissioner Bilberry stated the map they are looking at was never presented.

Commissioner Cavin stated that all that would happen would be that precinct 5 would move from District 3 to District 1. This would be the only change made from the current districts.

Frank Sanchez

Mr. Sanchez stated he had not planned to speak because he thought they had already chosen one of the three that had been made public. He stated it's very unfair to then give them generalities without any maps. He has no idea what they are proposing. It's very unfair to the public and they are not being transparent at this point. They should have presented this online to the public. Because there are no maps, no data, no statistics, he is still in favor of map E. He stated if you're going to do fair districts, a big part of that is being transparent and giving the public the opportunity to know what you just did with this amendment. Commissioner Cavin asked Mr. Sanchez if he had an issue with what our current districts look like right now. Mr. Sanchez stated he was not in favor of them ten years ago.

There were no comments online.

Further discussion from the Commissioners:

Commissioner Ezzell stated he assumes the demographer is still under contract, so he doesn't know why he didn't do what was asked nor is he here today. It was his understanding that after their meeting last Friday he was going to do the statistical analysis on paper for what moving precinct 5 into district 1 would do. He is hesitant to make the motion he already made because we're going off what he told us. He confirmed with the County Clerk that precinct 5 is contiguous to Commission district 1. He would like to see things on paper and stated they may have to have a special meeting.

Commissioner Cavin stated they could have a special meeting on Thursday, December 30th. Mr. Williams stated that if they have an emergency meeting, they will move agenda item 9 to this meeting. It was put on this agenda as an emergency, but they can move it to the 30th and advertise it properly. On Monday they got notice from the Association of Counties that the opioid settlement needs to be signed by January 2nd.

Mr. Williams stated this resolution opposes the proposed Lincoln National Forest Land Management Plan because the US Forest Service failed to coordinate with local governments in the development of the plan as required by their process. Staff recommends approval.

Commissioner Cavin stated this is obviously a big deal because they've been butting heads with BLM on the Carlsbad Research Management Plan and now the Forest Service comes in on the back side. This affects Lincoln, Otero, Eddy, and Chaves counties and Federal agencies are supposed to be coordinating with local governments not just showing up with a plan saying this is what we're doing you guys accept it and cooperate with us. Commissioner Bilberry stated it's very important that we work with all the counties involved in this. Lincoln County is going to suffer. Counties need to get their comprehensive plans up to date and start holding these people to the fire.

7. RESOLUTION R-21-059 - FINAL DISPOSITION FOR 2021 ROAD MAINTENANCE APPLICATIONS AND NEW ROAD REQUESTS

Presenter: Mac Rogers, Public Services Director

Mr. Rogers stated that of the 2021 road status applications, #3 Tierra Grande Blvd, #4 Veleta Drive, #5 Blanca Rosa Lane, #6 El Dorado Lane, Chaves County Road Department reports that each of these roads now meet the stipulations for acceptance as a county-maintained road. They are requesting permission to place them on the Chaves County Road atlas and to accept maintenance responsibilities.

Application #1, Thunder Road, Chaves County Road Department reports that the applicant worked hard to meet the standards for a new road request however, Thunder Road is pending the completion of a right-of-way request with BLM. Staff anticipates a recommendation to resolve Thunder Road as a County Road in February with fully acquired property rights.

New road application #2, Stagecoach Road, did not meet the requirements to be included as a new road and its status as a private road will remain in effect.

Staff recommends approval and final acceptance of Tierra Grande Blvd, Veleta Drive, Blanca Rosa Lane, El Dorado Lane, and Thunder Road as Chaves County Maintained Roads.

Tim Jennings, 2716 N Penn. #48, Roswell

Mr. Jennings stated on a Tuesday a couple of weeks ago, a member of the Elks Club was returning home and going down E. Country Club, a car pulled up and cut him off in the turning lane, a guy got out of the car with a gun. The member drove off, his car was shot, and the individual was shot. This is tragic and scary. That intersection is dark and it's very difficult to see anybody there. As Mr. Jennings was talking to a former State Police Officer, he was extremely complimentary of the way the investigation was held by the Chaves County Sheriff's Office. Mr. Jennings is unaware of how much investigative training they have but he thought it was worthwhile to mention that those officers have done a great job. He appreciates the training that the officers have, and he wanted to bring it out. When someone does a good job, it should be spoken of. This is deeply concerning to him and has made him want to carry a gun. The public needs to know about those individuals because if they did it once they will do it again.

MANAGER'S COMMUNICATION

Mr. Williams thanked all staff for doing a great job. He wished everyone in the County and all employees and the city a Merry Christmas. The US Forrest Service is running a campaign, if you want to call it that, parallel to the Carlsbad Resource Management Plan. While we were fending them off, they were doing something totally against the processes they have in place. Margaret knows this stuff inside and out and pretty much everything they were supposed to do they didn't do, and they certainly didn't coordinate with us. BLM was trying to make lands with wilderness

characteristics, these are actual wildernesses they are going to turn them in to not just wilderness characteristics so that's even a step further than BLM was trying. Had it not been for the landowners we wouldn't have known anything about it. When we commented to them that they had not communicated with us they said they'd give us until the 15th to make comments. They sent a 1500-page document for us to read and make comments. Margaret was able to find everything in there and was able to prepare those comments for us and we got them sent to the Forrest Service in a timely manner. We will see where this goes and hopefully, we can continue to fight for the people in our community that ask for our help.

They are planning to increase the solar out on Pine Lodge Road by 30 megawatts. They have sent us their negotiated pilot which is considerably less than the first solar plan. We are talking to them about trying to get this number up. This benefits the Roswell schools, and they get a certain percentage. We feel like we need to stand tough and have them come up on the amount they've offered. He thanked everyone for the great job they do and for the values we have here in Chaves County.
