among the hardest working and most productive in the United States and whereas the economic impact derived from the Agricultural Industry is vital to all citizens of Chaves County and whereas the Chaves County Board of Commissioners recognizes and appreciates the efforts of all Farmers, Ranchers and Dairy Producers as well as their families and employees for the financial strength and the stability they bring to our local economy and therefore the Chaves County Board of Commissioners hereby proclaims March 24<sup>th</sup>, 2022 as Agricultural Appreciation Day in Chaves County. #### UPDATE ON THE ECONOMIC DEVELOPMENT CORPORATION

Presenter: Mike Espiritu, President

Good morning, Mr. Chairman and Commissioners, It's a great time to be in New Mexico Isn't It, especially in Chaves County. Couple of things to bring you up to date on, I just attended recently the site selectors guild, we're a partner to this organization and its consultants that are actively working on projects across the globe. I met with about 24 different consultants, and we have one possible project as a result, so we will see how that comes along and its an Aviation project. Ascent Aviation, to give you an update, they are on track, and we have had some bumps in the road, but so you know they have hired 17 people already right here in Chaves County. They've already started demoing an aircraft here at the air center. They're also leasing additional buildings at the air center as well as some office space and anticipate being in their hangar by the fourth quarter of this calendar year, which is pretty exciting. That is phase one and then phase two is a second hangar and we will talk more about that as it comes along. As you know, I've been very involved with career tech education throughout our County, spent a lot of time with folks from the lower valley, particularly with Hagerman.

Just yesterday we hosted a career connections event that included all the districts in the County and brought everyone together to include the Pecos Valley Education Co-Op and what we talked about was how we can bring industry partners more to the table to help create the information for the pathways for young people in the different career fields. We brought a company in called NEPRIS, I've met those folks before, it's an online platform that provides an enormous amount of information to help not only the students but the education community and there will be more on that to follow up but we're pretty excited about that. We are working towards a Regional Consortium of all the school districts and how we can use that platform to really help our education community to move this forward with the young people for their success. Recently we worked with NMMI, one of two so far on industry days and this past one was on healthcare and we saw over 80 cadets and anxious to see how that goes and the next one will be on April 4th Law Enforcement Day and security things of that nature. We already have a number of industry partners there and I believe our Sheriff's Department will be there as well so thank you for that. Good to get that word out to the NMMI cadets. We have attended some and you may have heard about these opportunity fairs, I mentioned last month about the enormous amount of students that are being dropped from school rolls because of attendance for whatever the reasons are a very large number. What Roswell ISD has started is an opportunity fair to try and bring the students back to school, to continue school and graduate one day. So far, It is working, we don't see the numbers where we'd like or what they would like obviously so we're going to have another one in the near future.

Very involved with CAVU aerospace at the air center and as you know CAVU is another one of our emerald companies as they continue to expand, they have more work than they have people, like most businesses. But with CAVU they've also been very involved with our schools, in fact,

today they are going to be in Hagerman and doing a presentation to students at the high school. I find that pretty good that they're involving the folks in the lower valley as to what's available in the aircraft industry. We've also been working with Job Corps and New Mexico Youth Challenge, and I think it's real important because there are students there as well as in our County and as you know the Youth Challenge those are students from all over the state and whatever we can do to help those young people to a pathway to success and maybe stay here for jobs that we have right here in Chaves County is our goal.

We had a recent meeting with MET, Inc., not sure if you know about MET, Inc. They are a company funded by the Department of Labor and they provide opportunities through the National Farm Workers Jobs Program, I'm not sure if you know about that or not but they provide funding for young people linked to the agriculture industry throughout our state but particularly in the Southern part of our State. So, we're partnering with them through our extension services folks to reach out to our local farmers and ranchers, anyone tied to the agricultural where young people at the age of 18 or over can access funding that will help pay for wages and training and all sorts of things. Even if they go to the University, it will even help pay for some of their incidentals, room and board, things like that. We're pretty excited about that to move forward and I will let you know how that transpires because there are people out there that can probably use those resources. We also met recently with the Dexter High School principal about a different kind of career day for the Dexter high school because we can hopefully get those folks online to help their students as well. As you can tell we're doing a lot of work throughout our County to help our young people.

On our business retention side, we continue to assist local businesses in our County, we have one business right now that we've been assisting with and working with the State that is in Roswell to grow. So It is an expansion of about 2000 square feet, a couple of jobs but that's a good indication of how our economy is moving along better here in the County. Last month we visited about 34 businesses throughout our County and checked in with them and I think the biggest issue with them, is still staffing.

Chairman and Commissioners, Good Morning. Presented today is case Z-2022-01 to approve or deny special use to allow a second residence on a lot in Area 2, Zone A agricultural residential district. The agent and caretaker Chris and Karri Everett wish to place a second home, a single-wide manufactured home at 6590 Old Dexter Highway in Dexter NM for the care of their elderly mother, Diana Henson that currently lives on and owns the property. The subject property and the surrounding properties are zoned A agricultural residential as well. The second residence would be placed directly west of the existing home with a new septic system placed further west of the proposed new home. Both homes shall be served by the existing domestic well as permitted by the New Mexico Office of State Engineer. The property size is sufficient to allow a second septic system based on the New Mexico Environmental Departments requirements and State Statute 20.7.3.302. The Planning and Zoning Commission recommended approval of this special use permit with seven conditions of approval by a vote of 4-0 based on findings of fact 1-

5 stated in staff's report. Staff recommends approval of this special use, also there is an agreement letter as part of the staff report, for which, if approved Ms. Henson will sign and we will have notarized and filed with the Chaves County Clerk's Office.

# 8. APPROVE FISCAL YEAR 2022-2023 LAW ENFORCEMENT PROTECTION FUND APPLICATION

Mr. Chairman, Commissioners, Good Morning, Item #8 is the application of the Law Enforcement Protection Fund. Through the Law Enforcement Protection Fund, Chaves County is eligible for a total of \$79,000.00 for Fiscal Year 2022-2023. This money will be used to purchase and/or fund the following: ammunition, targets, portable radio batteries, pepper spray, graphics, and assorted police equipment. Prior to 2022, the LEPF distributed \$20,000.00 to local agencies and

\$600.00 for each Certified Law Enforcement Officer that they had with their agency. In 2022 they revamped that and now we receive \$45,000.00 straight across the board as a Sheriff's Office with \$1,000.00 per Certified Officer. We currently have 34 Certified Deputies with us for a total of \$34,000.00 plus the \$45,000.00 which equals the \$79,000.00. The distribution will be \$10,000.00 into line item 224 - Travel Training Per Diem, \$10,000.00 to line item 225-Supplies and tools, including ammunition. Into line item 230, for a total of \$29,500.00 - non-expendable supplies, including firearms, replacement firearms, parts, things such as that in line item 231, \$29,500.00. Staff recommends approval and acceptance of these funds. I stand for any questions.

# **RITA KANE-DOERHOEFER:**

Mr. Chairman, Commissioners, secretary for Keep Chaves County Beautiful. Let's start with facility maintenance, thank You Sandra, Where'd she go, she left, anyway we just spent \$763.00 on red rubber tire mulch to go at the Court House. I want to thank Scott, we were out there for an hour talking about certain things that needs to be done at the Court House. Number two, I am spending money as fast as I possibly can on cleanups, by the way we have the scouts, not boy scouts or girl scouts but the scouts, on the walking trail on April 2<sup>nd</sup> at 9am. If you want to come help us, that's a Saturday, We'll give you pickers, bags and gloves and I will instruct you on how to properly pick up trash. There is an art to picking up trash. Thank you for approving, or maybe they haven't approved it yet but thank you Bill, thank you Mac for approving the Court House lawn for the two events. The one in July, which I don't know what they're calling it and the Chili Cheese and thank you Joe West for giving us a roll off, because the city does not want us throwing our trash in their containers.

This is going to be, I'm going to sandwich the bad stuff in with the good stuff, the bad stuff is and I am not threatening, please do not think I'm threatening, I'm promising. This is a package deal we have to spend \$4,405.00 and change on two large trees for the Court House and this is where Scott and I met discussing what trees, I have called, I have e-mailed, I have messaged on Facebook. If we do not spend this money we do not get the camera's. So everything has to be in by March 31st, it has to be at the State on March 31st. So I have called, I have tried everything short of going to Texas and buying the trees, but we have to get this done or we lose not only the money for the camera's but the money for the trees and we will never get it back again, not next year.

Now the good stuff, I want to thank Anabel, Georgianna, and Lucia and everyone in the Finance Department for helping me do paperwork, I do not do paperwork very well and we've had 11 cleanups, or we're doing 11 cleanups and I do the paperwork and then Georgianna fixes It for me, and we get it done. We had \$4,400.00 to spend and I will spend every dime of that, I was with 40 students from Goddard yesterday picking up trash. Alright, we have another grant cycle coming up, we do have the Grant on hand, and we have one month to fill it out. This is for the

Grant Cycle 2022/2023 and the Board voted, I did not persuade them at all, we are now doing tree, shrubs, and plants at the Joy Center and then I got this letter and I do have this friend, because she calls me her friend here and it says, "That is fantastic Rita." She has solicited \$250.00 to help with the Arts and Crafts building at the fairground and it says, "Thank you, your friend Candy" So I do have a friend and we're going to work and we're going to spend thousands of dollars at the Fair Board because we were asked that we need to give the County a break in planting and putting everything in. So, we're going to the Fair Board and it's going to be Candy, Rick Ford, Sean and myself, that are going to go out there, I guess you can come too, if you want. (Directed towards Commissioner Ezzell) But Sean said that he can handle Candy and me, I'm not so sure about that.

Last but not least, this is one of the first years that the University of Miami is in the basketball tournament, the Cubs are on today and the season starts on my birthday. Remember last Thursday when I said that I quit talking to the Governor, I quit writing to the President but I wrote two e-mails to Robert Manfred and guess what, that afternoon they settled the strike. So anyway, Baseball season, Basketball Season, Thank you. Does anybody have any comments?

Commissioner Dana: I do have a question, the trees you're talking about, you can't get anybody to call you back?

Rita Kane-Doerhoefer: No, I can't. I've emailed and I've also private messaged him on Facebook. We're talking, Commissioner Dara, of 4-foot balls, we're talking about big big trees, Red Crimson King Maple. We're right on the border for the Maple, we bring them in, and I am hoping we can get the man in Ft. Sumner to sell us the trees if he ever opens. Then, I'm hoping to sweet talk Commissioner Bilberry in bringing them down for us. Joe, thank you Road Department, has already said that he will dig the holes, we're talking about big holes, 4 feet long on the Court House Lawn and the other one is a Red Crape Myrtle, if we can get it, I will take anything at this point, a Sycamore, I'll take anything except an Elm. So, if anybody knows anyone, The Greenery will not call me back. I have heard that maybe the Greenery was sold, but no one can get ahold of them. I don't know where else to go and I am not running around Texas, I am telling you that right now, I am not going on a road trip to Texas. So, if we don't get it then we lose that money and we lose the cameras because that's what we promised the State and she looks at everything and I mean if we say two trees, \$4,405.00 and change and she wants to see it to the penny. We also bought a lot of gloves, because when we go out to cleanups, we give them gloves and we're almost done with the latex gloves, Thank God. So that's what we're doing, so if anyone knows anybody that has a tree farm they don' have the big trees in Ruidoso, I've called down to Carlsbad and they don't have the big trees and we have 13 days, and we not only have to get the estimate to the penny, but we also have to write the BAR, the BAR is moving money from here to there. I have wrote the Arbor Day foundation but the biggest tree they have is like \$500.00. The thing is we cannot pay for transporting the trees. We cannot pay for digging the holes, but Joe said he can dig the holes for you, but this is very important we will lose a ton of money and then they won't approve any cameras for us or huge trees again.

I haven't talked to anyone, nobody will call me back. I'm serious, I came in there and I cried on Mac's shoulder, I cried on Bill's shoulder. I don't know what to do anymore, we need those cameras out at Midway. It doesn't matter if they're in the ground or not, we can heal them in for 2, 3, or 4 months and we can leave them out at Facility Maintenance, I don't know if their big enough or the Road Department and see if we can get them to heal in the trees for us and they'll just have them at their site. But this is very very important. Ok, no more questions, Go Cubs, Go Canes. Thank You.

#### **MARVIN CLEMENTS - 6102 KINCAID**

I live right out here by the airport and I have got a problem with my neighbors, I've been complaining to Planning & Zoning and he's been kind of working with me on all this stuff. There is several different people and several different addresses, one of the properties has about 5 motor homes parked on it plus the house and there is people living in them, I guess the man claims to the Planning & Zoning guy that there is only two people living there. He's trying to get them evicted, but that's not true, but whatever. Now the other address is 302 Ryan St., this guy bought a piece of property, went on a little lot, moved in there no septic tank, no water, no electricity. He strips cars on his property, strips cars in the alley, I don't know what kind of facilities they use, he's encroached onto the neighbor's property next door and burned all this stuff, went across the street burning property, burning cars, burning trailer houses, stripping cars and whatever else. The Fire Department has had to come out there to do whatever and what I'm asking ya'll is you need to help us figure out how we can stop this mess before it ruins the whole neighborhood. I'm 70 years old and I don't want to smell smoke all night long. I brought some of my neighbors here, they live right there. We're all old folks, we don't want to live in a dumpy neighborhood where we have to smell smoke all hours of the night. The fire trucks come out there at 2 o clock in the morning, come out at 8 or 9 o clock at night, last night walk out of the house at dark and you can smell smoke in the neighborhood, plastic, whatever they're burning. These two residents, they're just junk, I would like for you guys to do something, I've been to the County Manager, I've been to Louis with Planning & Zoning. I've went to the Environmental Department, I've called Santa Fe Environmental Department, I've called the Sheriff's, I've done everything I can do and now I am here asking ya'll to listen to my neighbors' complaints and to help us out. I've got a bunch of old folks that live out there, I'm representing them, because they can't come, they're too ill. One neighbor is right there next to where all this commotion goes on and he is in surgery today, but he is old, old, old man and his wife has emphysema, she can't smell smoke all the time, they're killing us but ya'll don't have a burn ordinance. Junk cars, contaminating soil, living in a bunch of residences and a house on a property that has no septic system, we've got to do something to stop this crap, but anyway that's about all I can say.

#### **TOM SHIDELER - 305 HOBSON**

The people that he's talking about live just to the East and one is directly behind my alley, and you can never get down the alley because they always have it blocked and they have Harley Davidson's that they start up at all hours of the night, mostly around 2 to 3 o clock in the morning and drive around the block, come back and sit there at their house and rev them up and that's one of the biggest things I've got to go with, other than the smoke that comes right into my house and everything he said is true. I don't want to say too much more other than that but It's a real eye sore down there. They tore down a camp trailer that wasn't even on the property they owned supposedly and burned it out in the alley. Fire Department has come by there two times, I believe, over there at least. So that should do for what I have to say.

#### MIKE HERRINGTON - 6106 KINCAID RD

Everything they say is true, it's horrible, you go to bed at night they burn cars, they burn trucks, they burn trailers, and my son sits out there and pukes all night long. We need help. That's all I can say.

#### JOSEPH HERRINGTON - 6106 KINCAID RD

Everything my dad says is right, I have emphysema and I guess fumes from the cars and the smoke. They get me nauseous, and I vomit, throw up but it's just like a smoke cloud covers the whole neighborhood and it even lingers in the Allsups, you can see it in the air, it's weird and it just lingers, and the wind don't blow it move it or nothing like that, but that's all I have to say. Thank You

## **MARVIN CLEMENTS - 6102 KINCAID**

Do you guys know of anything we or I can do? Or that planning & Zoning can do? To see if we can't stop this problem. I'm asking please do something, you know, they're killing us, they're killing these old folks, they're killing me. We shouldn't have to live that way when we've lived there for 30-40 years. These people move in, and they just take over the neighborhood and nobody can do anything. That's not right. Thank you.

#### **COMMISSIONER EZZEL:**

Louis, where does that fall under our nuisance ordinance?

#### **LOUIS JARAMILLO:**

Chairman, Commissioners, we do not have a nuisance ordinance. We do not currently have an abandoned vehicle, both on the property and in the right-of-way, regulations, or ordinance at this time. We did look at one from Dona Ana County, but we want to get with the Sheriff's Department because we are going to need their assistance in dealing with vehicles that are in the right-of-way because P&Z doesn't have that authority.

#### **UNDERSHERIFF CHARLES YSLAS:**

He's 100% right, Louis and I have tried to work together, and we have worked together on this and we have been out to the area and I have researched every Statute that I can think of as far as abandoned property and abandoned vehicles. We have made contact; we've had vehicles abandoned in alley ways and what we've utilized on that is a right-of-way for emergency personnel and were about to get that one moved. The problem is that we don't have the teeth, that we need statutorily that we would need to pursue anything criminally. We don't have the teeth in an ordinance right now that we would need to enforce a county ordinance against it. So it is a nuisance, we've tried criminally, we've researched criminal statues, we've researched county ordinance and we just don't have a County Ordinance in place. We've looked at on the criminal side of disturbing the peace and when we talk about disturbing the peace, we have to convince a judge that it is disturbing the peace. So, we've resorted to and had the deputies go out and keep their body cams on as we're trying to build a paper trail and do everything that we can on the law enforcement side, working with Planning & Zoning so we can help these folks out. Like I said we need the teeth to be able to do that, we really do. I don't know when the nuisance ordinance expired, I do know the County had one at one time, I believe but that would be something I would ask the Commission to research and consider.

### **COMMISSIONER BILBERRY:**

Bill, do you know anything about the nuisance ordinance?

#### **BILL WILLIAMS:**

There was an ordinance I believe that it was only in effect for 3 years, is that correct Stan? And it was unenforceable, so they repealed it in '89 I think, It's been quite a while.

#### **STAN RIGGS:**

Yeah, it was something like that and then we had a weed ordinance that was also kicked out by the board, I don't think that we've had one since '89 any kind of nuisance one. We tried to do one in the early 2000s, but the Commission went ahead and tabled it and decided they didn't want to get into it, but that was more about outside storage, it included a lot.

#### LOUIS JARAMILLÓ:

Planning and Zoning Director Graham Pinkerton brought that before the Commission according to the minutes and that was a time when his life got threatened by residents who have a number of items on their property elsewhere and who are notorious for having these items on their property since then. Every time it was presented to the County Board of Commissioners, those 100 to 150 people do show up and they are loud about not wanting anybody dealing with their stuff. So, they will come out and there are a number of people, like Mr. Clements, who wish to have that particular ordinance. But when it comes time for that public hearing, we've seen that those numbers aren't there and they don't appear for a Commission Meeting.

#### PATRICK LAWRENCE CONNOLY - 2815 Encanto

Rita and I are both on the ETZ Commission, we've been fighting this same thing. We condemn a property, there is no way to enforce it. Thank You.

#### **COMMISSIONER BILBERRY:**

Doës anyone else have any further comments on anything that was said today? Thank you guys for your time and your comments.

#### **COMMISSIONER EZZELL:**

We hear you guys.

#### MANAGER'S COMMUNICATION

Bill Williams, Chaves County Manager

Mr. Chairman, Commissioners thank you and I agree, I am really glad to see the people from the community come out, the only thing that I disagree with Mr. Clements, is that it's not just a bunch of old people because Mike and I used to work together and if he's old that means I'm pretty old too so don't want that to get out. Seriously though, it is a serious problem and you've brought it to our attention, and I believe we all are working towards trying to find a way to make it work and that includes asking the environment department to uphold their end. You know when people dump sewage on the ground they're supposed to be the ones to stop it and we've encountered a lot of trouble in getting them to assist with that.

I'm really excited about the AG Day and Rise with Roswell, all the agriculturists in our community including Ms. Kormendy, It's really exciting to see the Proclamation and to go to the AG breakfast that will be on the 24<sup>th</sup> to thank the people that bring this into our community.

Happy about the health office and finally getting the chance to move forward as we all discussed when all this CARES money came through. You know 50 years from now, no one is going to remember that their grandfather got \$1,200.00 to buy a boat with or whatever they used it for. So we're glad we're going to be able to do something bricks and mortar that 50 years from now people in our community will be able to reap the benefits of. Thank you guys, for allowing us to pursue those avenues. Excited for the PVRCC, the bathrooms are getting close to being done. We're working really hard with the contractor to make sure he's out of the way so we can have our early voting back down there. We're going to make that happen, we're just not sure how close he's going to be to being done. Now we're going to start the design process with Ms. Best and other people from her department to build a good state of the art communications center and keep our Sheriff, Fire guys and all our First Responders safe.

Monday we're having a meeting here with the US Forest Service at 2pm. Representatives from Lincoln, Otero, Chaves and Eddy will all be there because none of us were included on any of the planning. They came in at the end and said here's what we're going to do, we're going to create wilderness areas and you guys don't have any say in it. By Law, they're required to allow us to participate in those events, so we're doing our part to make sure we get them back on track.
